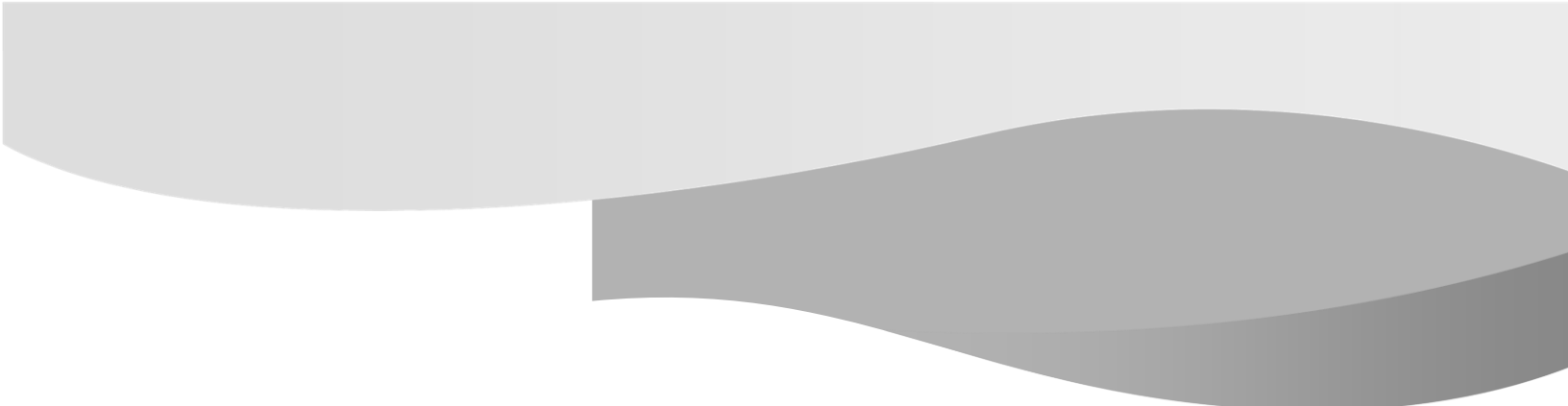

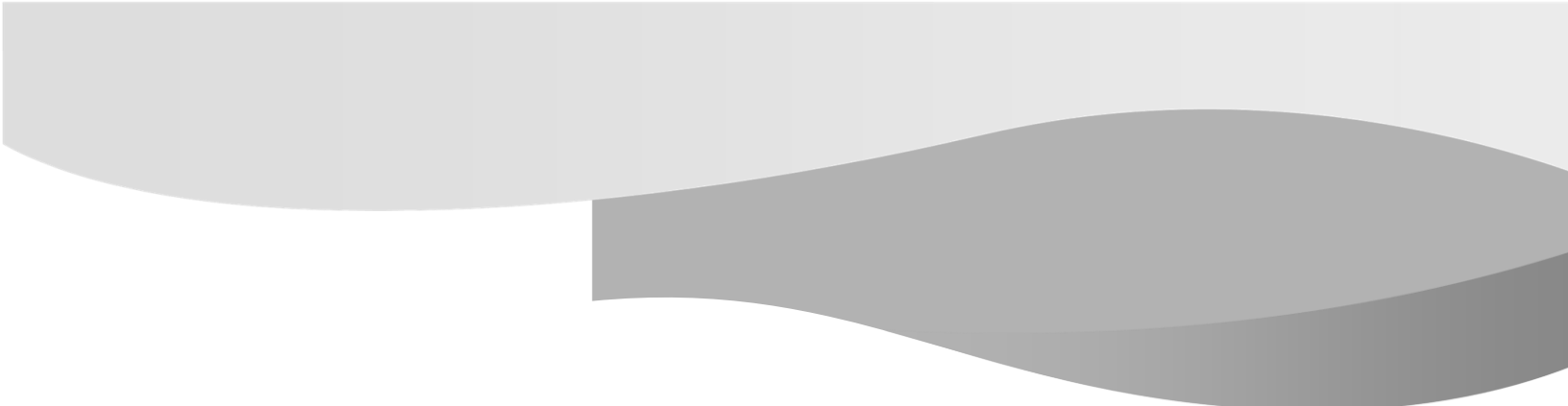

Voted and accepted by all Board members with 4 ayes. Approved.

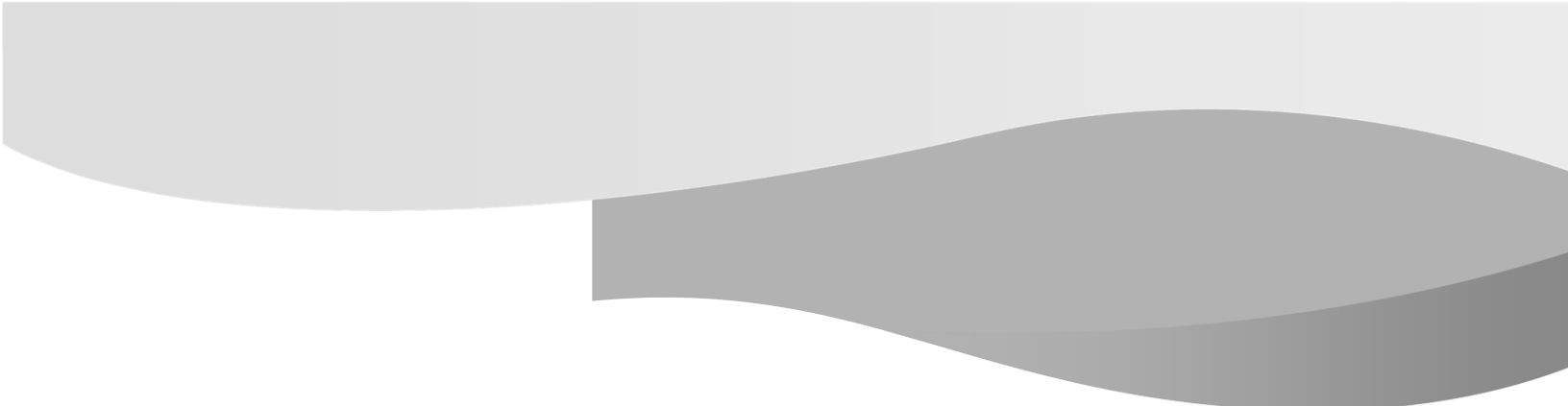


Treasurer's Report:

8/14/25 Meeting, Type up Aug draft minutes, Post July 2025 minutes as final and Post July 2025 money report.

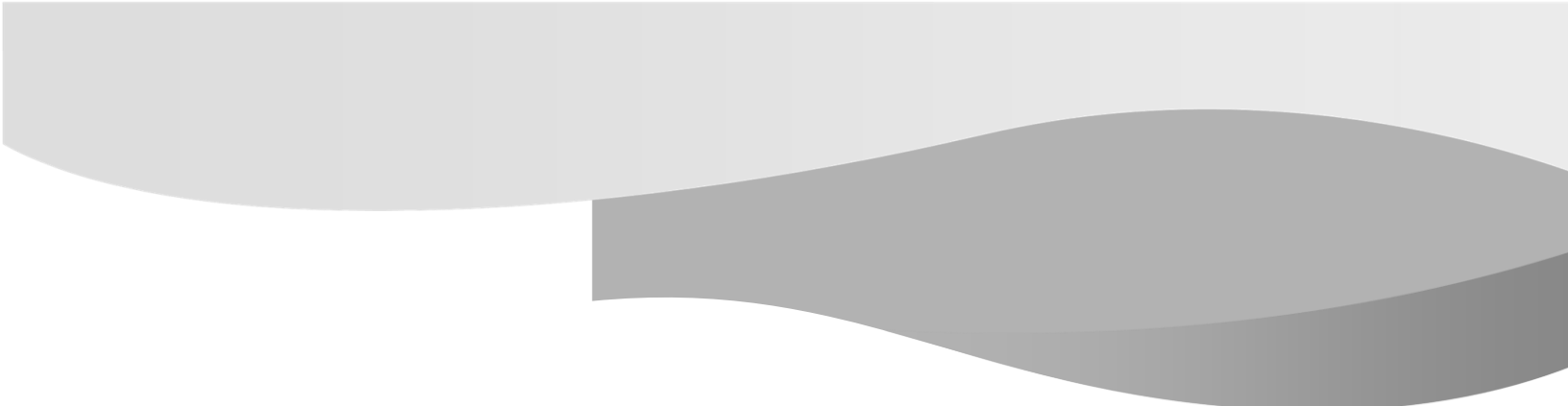
8/16/25 Mark Manor drive water services and Blakewood drive.

Starting January 1st 2026 The SGFD will raise the base rate by \$2.50 and the per gallon rate by 0.0010 cents per gallon.
