The following people have given their Intent to run for election:

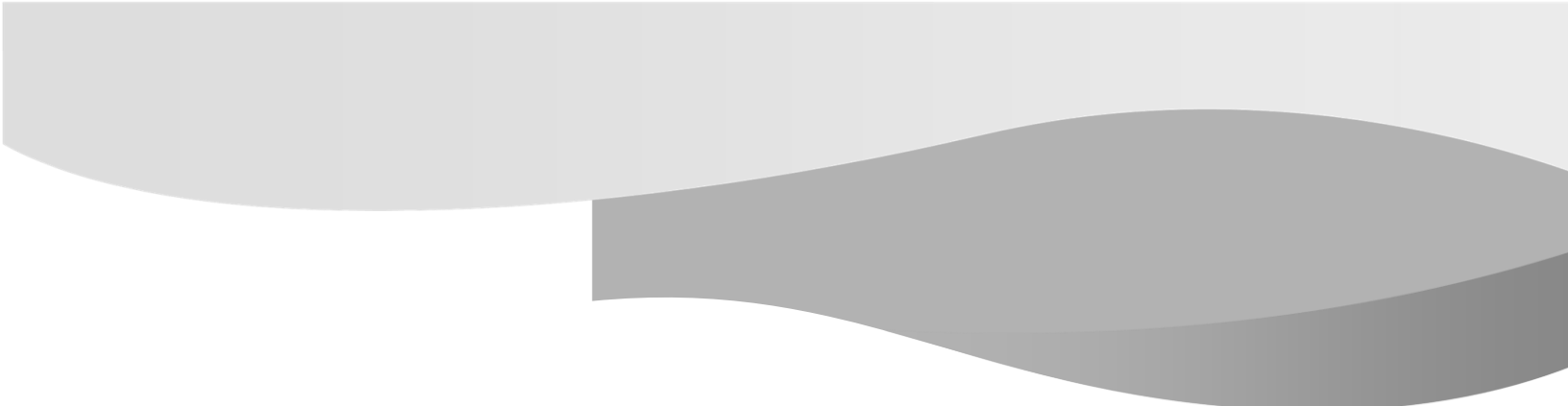
Laurie St. Gelais will run for a 1 year term as Committee member
